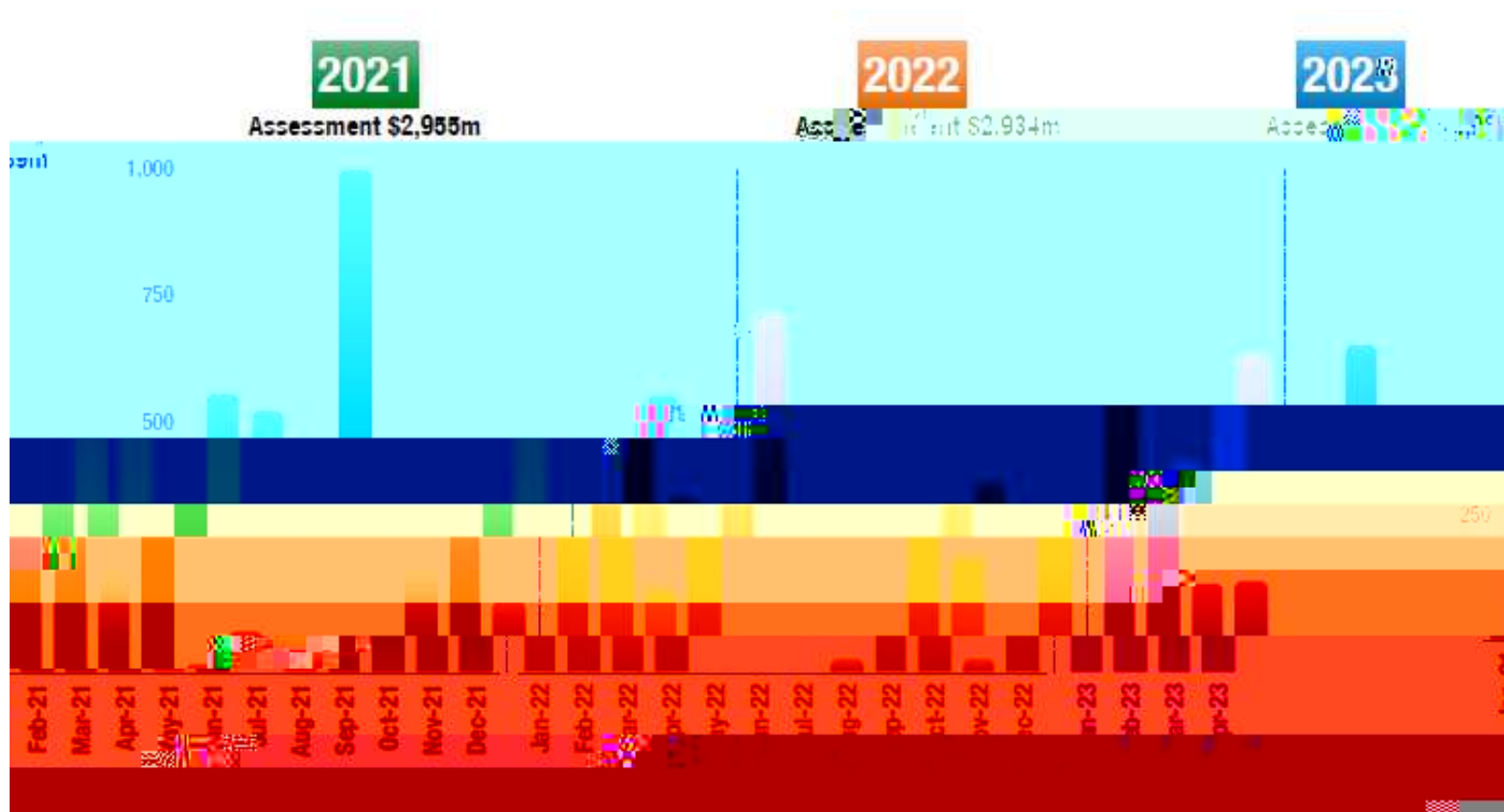


Chart \$ - Regular Budget Collection Trend

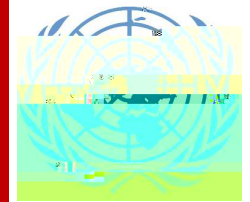

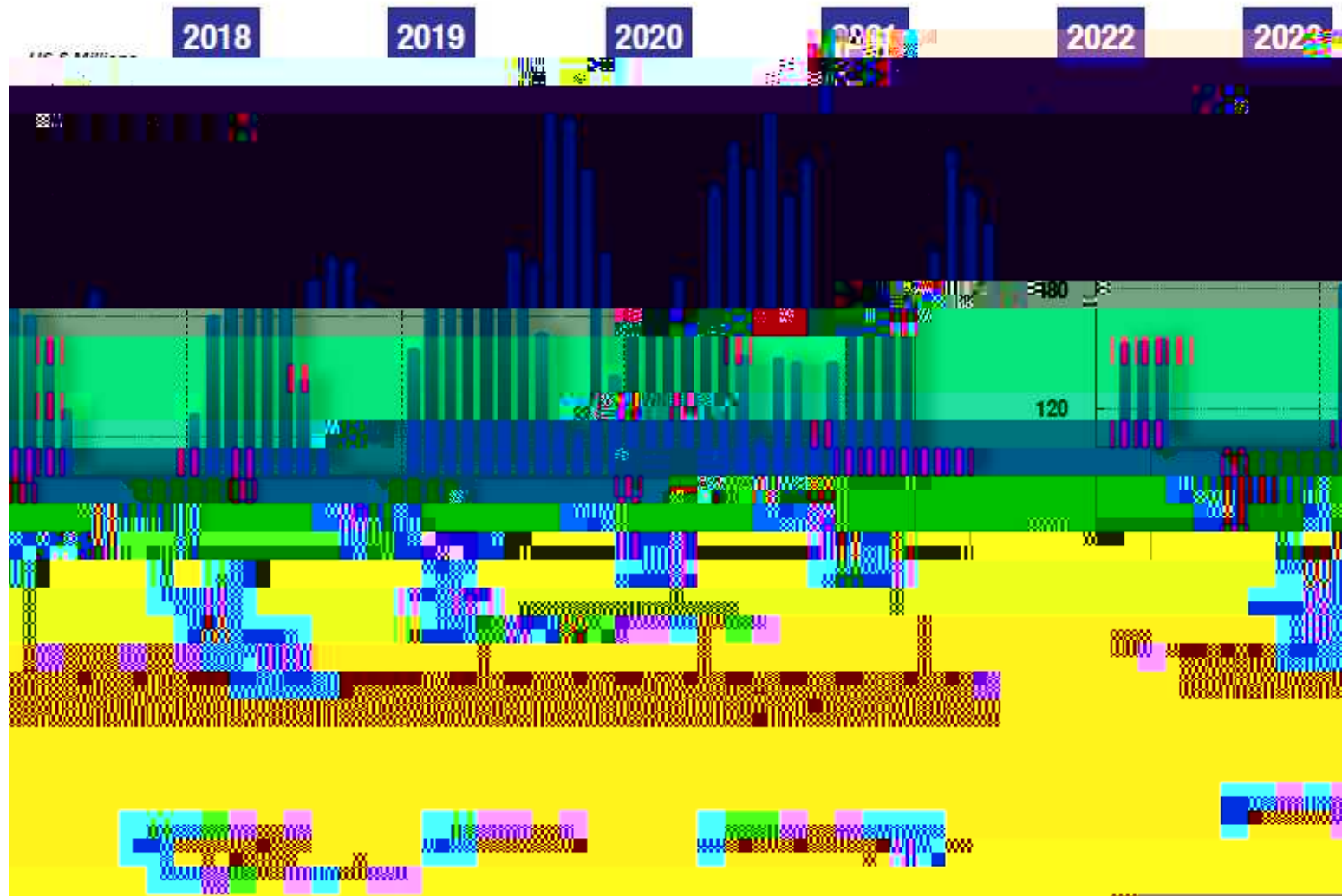
Chart 2 - Regular Budget Cash Balance Trend

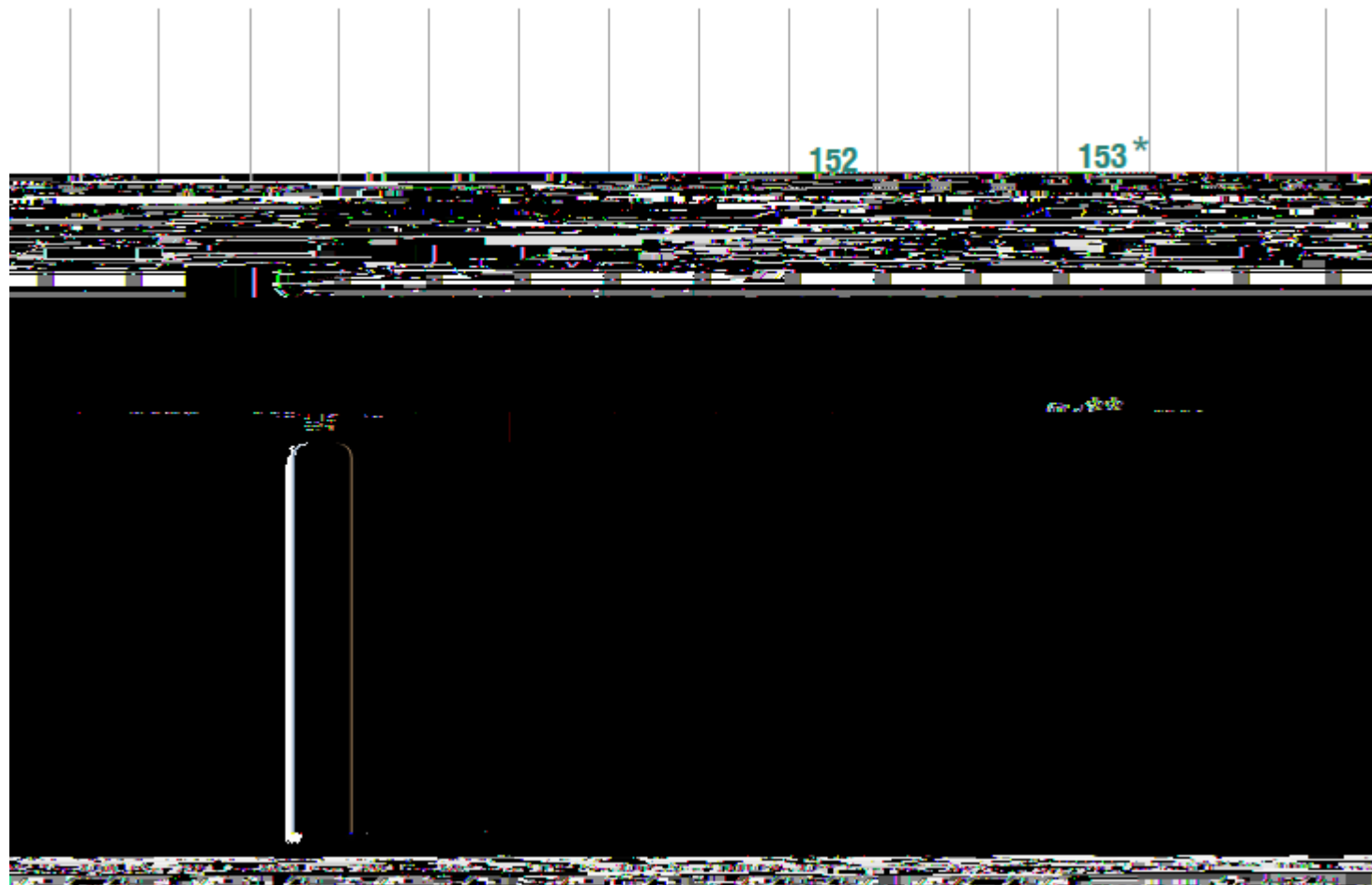

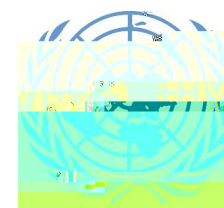

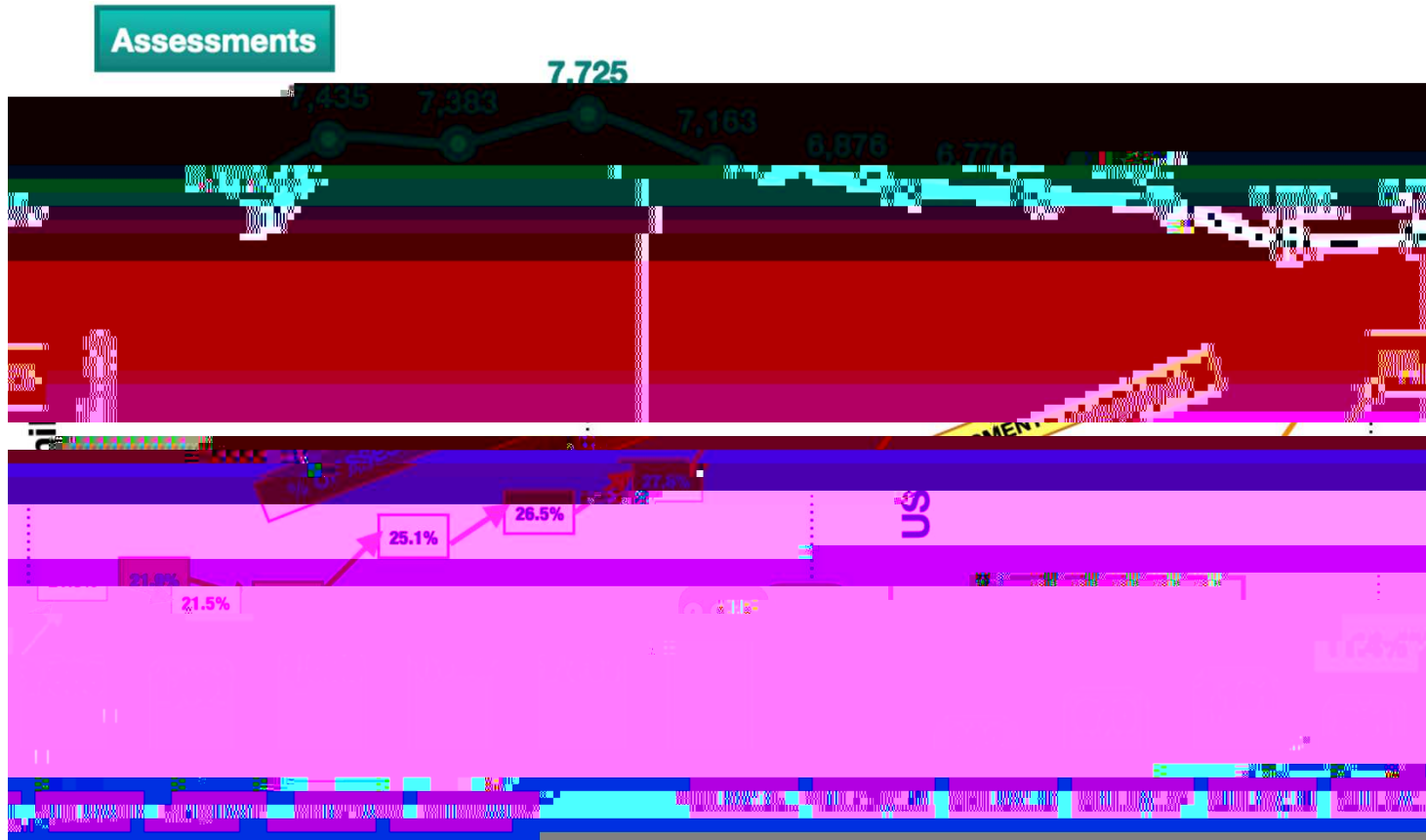


Chart \$* E >utstandin! contri&utions at #eace' ee#in! ;iscal year end (US\$ millions)

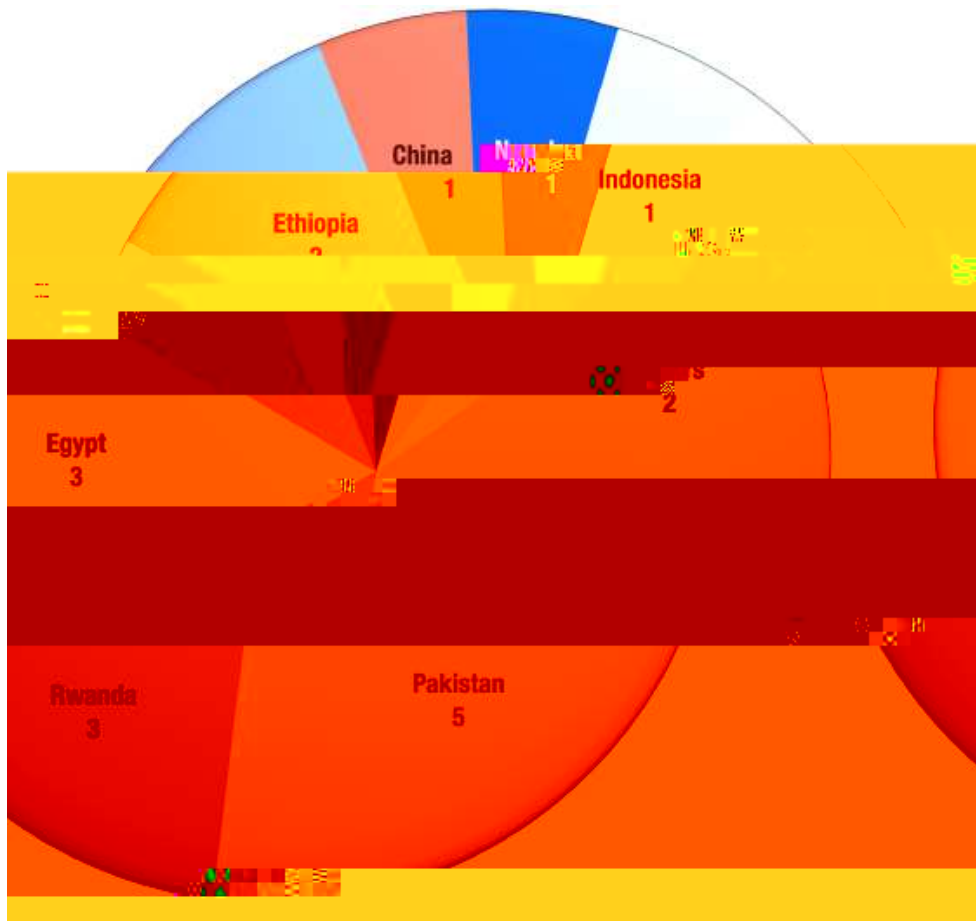

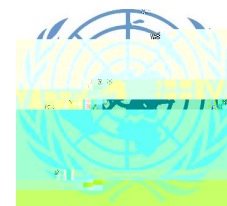

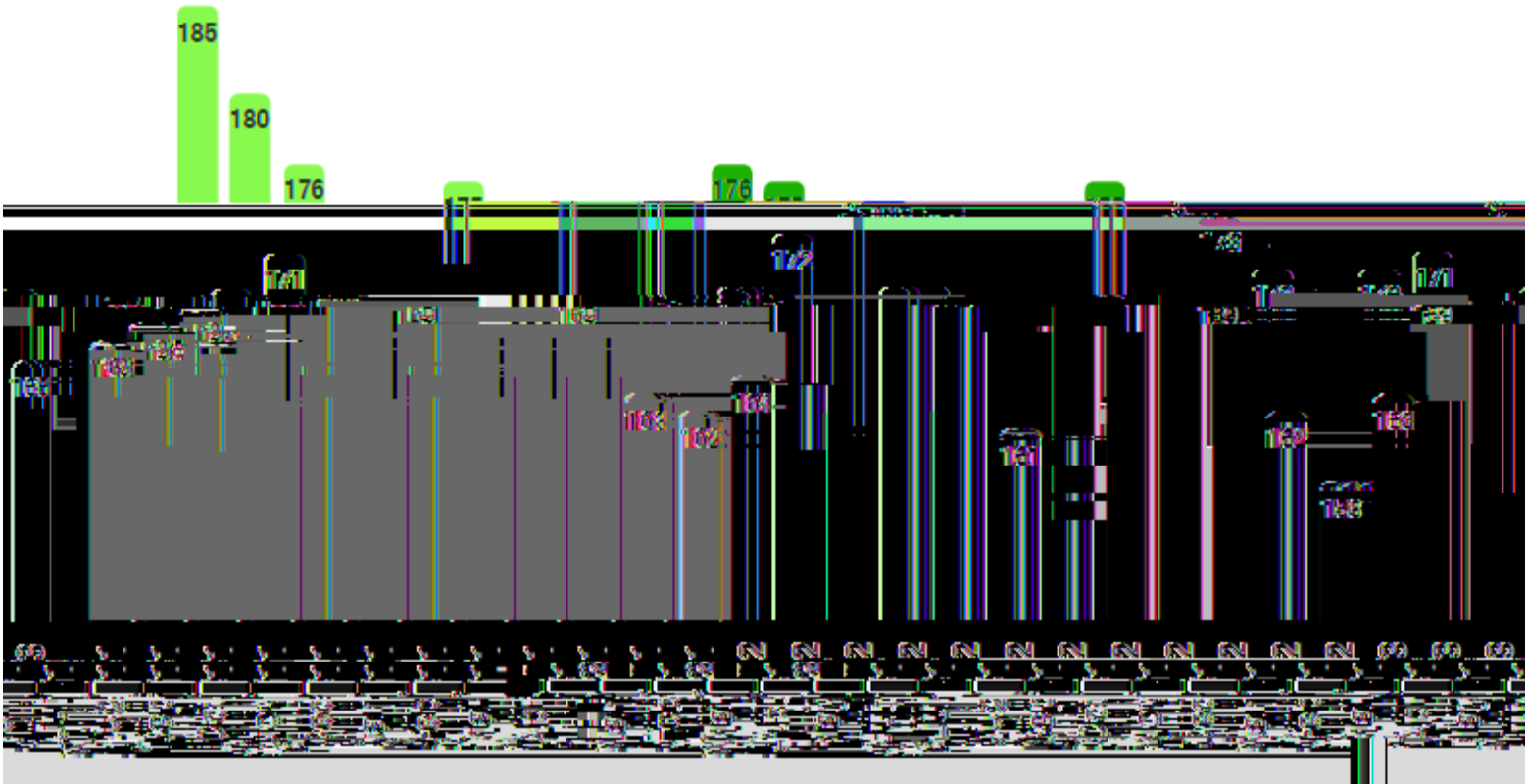

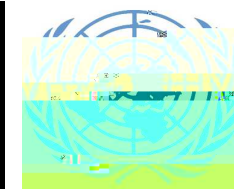
