



MISSION STATEMENTS OF CHIEF

Your Excellencies,

Ladies and Gentlemen,

Since January 7th, 2009, I have had the privilege and honor to chair the Peacebuilding Commission, created in 2005 by the General Assembly resolution 60/180 and the Security Council resolution 1645, which established the conceptual and practical framework of the United Nations peacebuilding architecture, also including the Peacebuilding Support Office and the Peacebuilding Fund.

Much progress has been made since the Commission's creation. Not only are there four countries on its agenda, but also the Fund is assisting 15 countries by financing over 100 projects. The Fund has continued to attract generous contributions from more than 40 countries.

The countries on the agenda at different stages of advancement towards

Relations with the Economic and Social Council were expanded with the participation of the Chairman, both in seminars and sessions of the Council and through the joint organization with the World Food Program regarding the debate on the economic, financial and food crises in post-conflict countries, in which the World Bank and the International Monetary Fund also participated.

Regarding the relation with other partners in peacebuilding efforts, I would like to highlight that my first trip as President of the PBC was to Washington D.C., where I met the highest authorities of the World Bank and the International Monetary Fund, in order to strengthen the Commission's bond with international financial institutions in the common task of peacebuilding. In the same way, contacts were established with the OECD to discuss ways to supplement our efforts for post-conflict countries.

In my efforts to improve the visibility of the Commission, I made contact with ~~personalities from various backgrounds involved in the quest of peace and with civil~~



This year there will be a review of the Commission's founding resolutions, for which the President of the General Assembly has already appointed three facilitators. As a member of the Commission, Chile will continue to extend its full support and cooperation to this important process.

In my opinion, the 2010 review should focus on the substantive topics before us and not on procedural matters. In this way, we shall be able to improve the performance of the Commission and its services to post-conflict countries. We must develop the added
