# TENTATIVE FORECAST OF THE PROGRAMME OF WORK OF THE SECURITY COUNCIL FOR THE MONTH OF AUGUST 2013

#### For information only/not an official document

This tentative forecast of the programme of work of the Security Council has been prepared by the Secretariat for the President of the Council. The forecast covers in particular those matters that may be taken up during the month pursuant to earlier decisions of the Council. The fact that a matter is or is not included in the forecast carries no implication that it will or will not be taken up during the month: the actual programme of work will be determined by developments and the views of members of the Council.

#### **Sudan (Sudan/South Sudan)**

### Resolution 2046 (2012) of 2 May 2012

Para. 6: requests the Secretary-General to consult with the African Union on the implementation of this resolution and the decisions of the AU PSC, to work closely with the AUHIP in support of its facilitation efforts, and to inform the Security Council within 15 days and in two week intervals thereafter on the status of compliance by Sudan, South Sudan, and the SPLM-N with the decisions set forth in this resolution, and expresses its intention, in the event that any or all of the parties have not complied with the decisions set forth in this resolution, to take appropriate additional measures under Article 41 of the Charter as necessary.

#### S/PRST/2012/19 (2012) of 31 August 2012

Penultimate para.: recalls its Resolution 2046 and reiterates its request to the Secretary-General, in consultation with the AUHIP, the Chair of IGAD, and the Chairman of the AU Commission, to report to the Council by September 2 on the status of negotiations. The Security Council also looks forward to reviewing the AU's determinations as indicated in paragraph 18 of the AUPSC Communiqué of August 3 and requests in th

Para. 25: Requests the Secretary-General to keep it regularly informed, and to report to the Council on the implementation of MINUSTAH's mandate, semi-annually and not later than forty-five days prior to its expiration;.

Para. 26: requests the Secretary-General to include in his reports a comprehensive assessment of threats to security in Haiti, and to propose, as appropriate, options to reconfigure the size and composition of MINUSTAH and to further develop, evaluate, and submit as an annex to his next report, the consolidation plan presented in Section VI of the Report S/2012/678;

## S/PRST/2007/24 of 29 June 2007

Para. 5: underlines the need to address this issue and in this regard, requests the Secretary-General to submit to the Council, on a biennial basis, a report on small arms containing his analysis, observations and recommendations as well as his observations on the implementation of the United Nations Programme of Action to Prevent, Combat and Eradicate the Illicit Trade in Small Arms and Light Weapons in All its Aspects, to facilitate its further consideration of the matter.

The report of the Secretary-General is expected to be issued in August 2013.
