**Mali: Sanctions: SC to review Panel of Experts mandate**

Resolution 2484 (2019) of 29 August 2019

Para. 3: Decides to extend until 30 September 2020 the mandate of the Panel of Experts, as set out in paragraphs 11 to 15 of resolution 2374 (2017), as well as the request to MINUSMA, as set out in paragraph 16 of resolution 2374 (2017), expresses its intention to review the mandate and take appropriate action regarding its further extension no later than 31 August 2020, and requests the Secretary-General to take the necessary administrative measures as expeditiously as possible to re-establish the Panel of experts, in consultation with the Committee, drawing, as appropriate, on the expertise of the current members of the Panel of Experts;

The Security Council is expected to review the PoE mandate no later than 31 August 2020.
