**CAR: SG reports on the situation in CAR and MINUSCA**

Resolution 2659 (2022) of 14 November 2022

Para. 58: (a) Requests the Secretary-General to report to the Council on 15 February 2023, 15 June 2023 and 13 October 2023, including on: the situation in the CAR, including the security situation, the respect by all parties of the ceasefire, the political process, the implementation of the APPR, including efforts made by MINUSCA to support the ceasefire and DDR process, progress on mechanisms and capacity to advance governance and fiscal management, and relevant information on the progress, promotion and protection of human rights and international humanitarian law and on the protection of civilians; – violations of the Status of Forces Agreement and follow up on efforts to hold perpetrators accountable, including through joint investigatrato .0032 0 0 15(n)2thuksllORra. 58ttack the (rorov23(rccy 20).0032m

Resolution 2444 (2018) of 14 November 2018

Para. 4: requests that the Special Representative of the Secretary-General and Head of the United Nations Assistance Mission to Iraq (UNAMI) promote, support and facilitate efforts regarding the repatriation or return of all Kuwaiti and third country nationals or their remains, and the return of Kuwaiti property, including the national archives, seized by Iraq, further requests the Secretary-General to report separately to the Security Council on these matters in his reports on the progress made towards the fulfilment of all UNAMI's responsibilities...;

The report of the Secretary-General dated 19 January 2023 (S/2023/51) is before the Security Council.

**The situation in the Middle East, including the Palestinian question**

Resolution 1322 (2000) of 7 October 2000

Para. 7: Invites the Secretary-General to continue to follow the situation and to keep the Security Council informed.

**Middle East (Syria): OPCW DG to report to SC (through SG) on implementation of resolution 2118 (2013)**

Resolution 2118 (2013) of 27 September 2013

Para.12: Decides to review on a regular basis the implementation in the Syrian Arab Republic of the decision of the OPCW Executive Council of 27 September 2013 and this resolution, and requests the Director-General of the OPCW to report to the Security Council, through the Secretary-General, who shall include relevant information on United Nations activities related to the implementation of this resolution, within 30 days and every month thereafter, and requests further the Director-General of the OPCW and the Secretary-General to report in a coordinated manner, as needed, to the Security Council, non-compliance with this resolution or the OPCW Executive Council decision of 27 September 2013.

The report is expected to be issued in January 2023.

**Middle East (Yemen): Sanctions: Assets freeze and travel ban**

Resolution 2624 (2022) of 28 February 2022

Para. 4: Decides to renew until 28 February 2023 the measures imposed by paragraphs 11 and 15 of resolution 2140 (2014), reaffirms the provisions of paragraphs 12, 13, 14 and 16 of resolution 2140 (2014), and further reaffirms the provisions of paragraphs 14 to 17 of resolution 2216 (2015);

The assets freeze and travel ban will expire on 28 February 2023.

**Middle East (Yemen): Sanctions: SC review of Panel of Experts mandate**

Resolution 2624 (2022) of 28 February 2022

Para. 15: Decides to extend until 28 March 2023 the mandate of the Panel of Experts as set out in paragraph 21 of resolution 2140 (2014), and paragraph 21 of resolution 2216 (2015), expresses its intention to review the mandate and take appropriate action regarding the further extension no later than 28 February 2023, and requests the Secretary-General to take the necessary administrative measures as expeditiously as possible to re-establish the Panel of Experts, in consultation with the Committee until 28 March 2023 drawing, as appropriate, on the expertise of the members of the Panel established pursuant to resolution 2140 (2014);

The Security Council is expected to take action no later than 28 February 2023.
